Program Aims

Instructors set up the groundwork for understanding current frameworks and emerging issues in regulatory policy design, compliance and enforcement from a multi-stakeholder perspective. Instructors take a multidisciplinary approach that helps trainees acquire skills and knowledge, and to apply them to interactions between deeply intertwined regional and global forces impacting markets' competitiveness, competition, patterns of technological change and structure.

Learning Objectives

A. Gain practical knowledge and understanding of:

- Fundamental valuation methodologies used by investment bankers, corporate officers, university professors, investors and other finance professionals.
- Structure and processes of the main types of auctions as a sell-side mechanism.
- Accounting standards for US public company financial statement reports.
- ESG factors incorporation into the investment and regulatory analyses
- The functions of financial intermediation and regulation, and the structure of the United States financial system
- Foundations of United States & global securities regulation
- The economic reasons for going public, and the regulation of initial public offerings (IPOs) in the United States
- Supervisory, enforcement, and international regulatory cooperation tools for capital market regulators
- The regulation of securities firms and asset managers, and their role and function in capital markets
- Best practices for protecting investors in financial instruments
- The relationship between corporate governance, investor protection and capital market development
- The fiduciary duties owed by directors, officers and controlling shareholders to the corporation/other shareholders
- The main features and evolution of corporate ownership structures
- New corporate governance problems arising from shareholder activism and the rise of institutional investors
- The opportunities, risks and regulatory challenges associated with the use of technologies in the financial industry
- The potential of technology for securities regulation and supervision
- The purpose, strengths and weaknesses of the current framework for gauging the implications of sustainability
- The legal and regulatory determinants of data regime for financial services within and across borders

B. Industry-Specific Skills:

- Hone analytical skills in order to integrate economic, financial, and legal angles to a broad range of regulatory activities, including rulemaking, enforcement actions, market oversight and monitoring
- Learn how to conduct sophisticated legal research on financial and securities regulation, as would be expected for regulators working in government positions or lawyers working in private practice

C. General Regulatory Policy-Making Skills:

- Craft concrete policy solutions to complex problems and make strategic policy recommendations that integrate economic, technological and international dynamics of regulated and shadow markets
- Use regulatory analysis and strategic perspectives to defend policy approaches, particularly in multi-shareholder environments

D. Method

- Interactive lectures, fact-pattern and hypothetical scenarios, in-class group exercises, case studies, and tutorials
